

## Arnside Public Toilets

## SLDC Funding Contract Meeting 10th December 2021

"Arnside Parish Council (APC) believes in the need to provide accessible and good quality public toilets because it affects not only the quality of our village, it's also about people's dignity and quality of lives. After all, they are one of the basic facilities that residents and visitors alike depend on. Whether it is families with small children or older people, it is important that people have the confidence that the facilities they need are available when they are out and about. - At the beginning of 2020, a project was initiated to modernise the existing toilet facilities. This was driven by :
  - need for essential repairs and maintenance
  - problems with accessibility
  - escalating operating costs including cleaning and maintenance
  - loss of income through theft of entry money
  - cost of repairing damage caused by vandalism.
  - the need for the facility to become self-financing
- As the result of an open tender process, a new managed service provider, Danfo Ltd, was appointed. The refurbishment work was carried out and the toilets were re-opened in July 2020, in time for the end of the lock-down and the start of the summer season. The project delivered:-
  - upgraded toilet block and facilities
  - new cashless entry system, including the increase of entry cost from 20p to 40p
  - significant cost savings on cleaning and maintenance through contract optimisation and change of service provider.
  - the toilets are now fully managed by Danfo, on behalf of Arnside Parish Council.
  - Danfo has delivered a consistently high-quality service since the start of its contract.
- We continually review and improve the toilet facilities and seek feedback from the public for input into this process.

- We will continue to review and re-forecast our position on a monthly basis
- We have some flexibility in terms of increasing entry income (up to approx. 25% (10p)) to offset any reduction in demand or incorrect assumptions.
- We will have an end-to-end review at year end.
